- (Yes or No) 6. Any crime that indicates the person may be unsuitable or unfit to have responsibility for safety and well being of children.

I acknowledge that the Washington County Recreation Department may choose to deny me a coaching position or may choose to deny me unsupervised access to a child or children pending the completion of the background check, and I further agree to hold the Washington County Recreation Department and/or the Washington County Board of Commissioners harmless regarding any liability for defamation, invasion of privacy, or any other claim based upon good faith action taken pursuant to the provisions of this consent.
